

LIABILITY WAIVER AGREEMENT

The obligation and duties associated with my position as a student intern for the Northern Marianas Technical Institute (“NMTI”) and _____ (“Internship Site”), which obligation and duties I acknowledge and accept, understand and hereby expressly agree:

That if I am accepted as an intern for NMTI and the Internship Site, in consideration of my participation in the activities, I hereby represent, warrant, promise, and agree that my participation is strictly of my own free will and choosing. I further warrant and represent that I understand that the activities may carry with them certain risks that may result in serious injury, including permanent disability or even death, serious economic losses due not only to my own actions, but also due to the actions, inactions, negligence, and intentional actions of others, or the condition of the premises at which the activities may take place. I also hereby warrant, represent, promise, and agree that by my attendance at or participation in the activities, I do hereby fully assume any and all risks associated with, arising out of, or related to my attendance or participation. This assumption of risk hereby expressly includes, but is not limited to, my assumption of the risk of negligent or intentional actions and omissions by NMTI and the Internship Site. I also further warrant and represent that I understand that NMTI is itself engaged in education and community service, and is not engaged in for-profit activity.

In consideration of my participation, I hereby represent, warrant, promise, and agree, that I do hereby for myself, and or my heirs, executors, administrators, and assigns, waive, release, covenant not to sue, and agree to indemnify and defend NMTI and the Internship Site from and against any and all claims for damages, illness, death, personal injury, loss of property or property damage, costs, attorneys’ fees, or other injuries, costs, or losses of any kind whatsoever that I may suffer or incur as a result, or that I may cause third parties to suffer or incur as a result, or in any manner associated with, arising out of, or related to my participation. This release, waiver, and covenant not to sue expressly include, but is not limited to, the risk of negligent or intentional actions, omissions by, and conditions at NMTI and the Internship Site.

I further hereby warrant and represent that I am in good physical condition, and do not suffer from any known condition which would prevent or limit my participation, and that my participation is purely for its specified purpose. I further represent and warrant that I have read and understand this agreement, that I understand that by signing it I may be giving up substantial rights, and that I have signed this waiver and release voluntarily with full knowledge of its contents and the consequences that may arise from it.
